### **Data Definitions**

### Patients Referred to Mid-America Transplant ('MT')

Number of patients referredd to MT by hospitals as a prospective donor

### Patients Referred to MT in a Timely Manner

Number of patients referred to MT by hospitals at least 3 hours prior to end-of-life discussions

### Percentage of Patients Assessed by MT at Hospital

Percentage of patients that MT assessed onsite at the hospital for organ donation. This is calculated using [number of patients MT assessed at hospital] / [all patients referred to MT]

### Percentage of Patients Assessed by MT at Hospital within 90 Minutes

Percentage of patients that MT assessed onsite at the hospital within 90 minutes of the hospital's call. This is calculated using [patients assessed by MT within 90 minutes of the hospital referral] / [all patients assessed onsite by MT]

### Missed Opportunities: Hospital Declined Family Conversation with MT

Number of times a hospital or family declined having a conversation with MT about organ donation

## Missed Opportunities: Family Decision to Withdraw Ventilated Support Occurred Prior to Family Conversation with MT

Number of times a decision to withdraw ventilated support occurred before MT could have a family conversation

### **Family Conversations about Donation**

Number of patient families that specially-trained MT staff spoke with regarding organ donation

### **Family Conversation Rate**

Percentage of patients referred to MT that had a family conversation about organ donation with MT staff. This is calculated using [family conversations about donation] / [patients referred to MT]

### **Families Supportive of Donation**

Number of patient families who indicated their support and consent for organ donation to MT

### **Family Consent Rate**

Percentage of patient families that had an organ donation conversation with MT staff that indicated their support and consent for organ donation. This is calculated using [families supportive of donation] / [family conversations about donation]

### **Patients Who Donated Organs**

Number of patients who donated organs with the intent of transplantation

### **Organs Transplanted**

Number of donated organs that were transplanted into patients on the waitlist
